TO RECEIVE REPORTS AND MATTERS RAISED BY COUNCILLORS

Cllr Pike raise the matter of the Council meeting at the Town Hall in Newtown with the National Trust and was told it could be possible. Also the suggestions coming from them regarding charging looks to be a fate comply.

He had raised the problem with the notice board and other people using our side of it. Cllr Mathrick reported back that the drains in the hall had been emptied on the 21st February 2017.

They had obtained 3 quotes for drainage works to be carried out. The Authorisation and inspection cost would be £450. The form for the grant is long and complex for a small committee to deal with.

Councillors reported that there had been 3 potholes repaired in 3 days between Colmans Lane and New Road and there was a 5 day closure notice in place.

The drain is leaking and water is running down road and there is now a sign saying spring.

It was reported larger vehicles are using roads at Calbourne.
