### 68/16 TO APPROVE THE MINUTES OF THE MEETING HELD ON THE 3<sup>RD</sup> OCTOBER 2016

The Minutes of the meeting held on the 3<sup>rd</sup> October were approved and duly signed.

## 69/16 TO RECEIVE REPORT FROM ISLE OF WIGHT WARD COUNCILLOR INCLUDING – ROAD SAFETY ON MIDDLE ROAD

Cllr Hutchinson reported on the following:-

- a. The Isle of Wight Council were waiting on the Autumn Statement on the 23<sup>rd</sup> November to see what the Islands received in settlement.
- b. The Isle of Wight Council has altered ways it pays its debt. This has resulted in £4 million saving.
- c. The Audit Commission now external audits.
- d. Staffing has been cut by a third, in some areas this was too much.

Cllr Hutchinson raised the problem of speeding on the Middle Road which has a 60 mph limit. He introduced the Council to the owners of Calbourne Mill who are experiencing problems with cars crashing onto their property causing a great anxiety as on a number of occasions people were there and by chance have not been seriously injured.

Mrs Chaucer talked to the Council about what they had experienced and the close escapes of visitors to the Mill being injured. Photographs were shown to the Councillors.

There are a number of issues from the camber of the road, the lack of a thick hedge to prevent cars going onto Calbourne Mill. The edge of the Road is not visible and there could be problems with the surface of the road at this point. The road is wrong and a hazard.

Calbourne Parish Council are concerned at the dangerous hazard this is continuing to cause to visitors and local residents and it is only by chance no one has been killed. Concerns were also raised about the lack of documentation on road accidents these days by the police.

THAT the Council support in principle that this problem of the safety issue on the Middle Road at Calbourne Mills

THAT determination what is appropriate to prevent cars going off the road. This is a matter of urgency and it needs a highway engineers report that would put pressure on the Isle of Wight Council.

Councillor Hutchinson to set up a meeting with Highways Engineer.

➤ Island Roads meeting with Kevin Burton

The Clerk reported on the Meeting she has had with Kevin Burton. The following matters were raised:-

- a. The Plan sent in by Calbourne Parish Council to have speed limits on certain roads reduced to 20 mph. This plan had originally been produced at the request of Island Roads.

  The update that she was given was that there was a list of 1500 outstanding local projects. Unless
  - the Parish Council will contribute to this i.e. cost of signage and other matters there is no hope of it happening in the future.
- b. Posts around the War Memorial. Calbourne Parish Council want them removing as they are not on Isle of Wight Council land and the Parish had not been asked permission for them to be installed. They detract from the Memorial.
  - The Isle of Wight Council installed them and this is a matter that Island Roads will have to refere to them.
  - The Council asked the Clerk to put in writing our complaints to Kevin Burton as well as the Isle of Wight Council.
