# 241/18 TO DISCUSS AND REVIEW THE CURRANT ROAD PROBLEMS WITHIN THE PARISH OF CALBOURNE AND BRING FORWARD RECOMMENDATIONS AND ACTIONS TO BE TAKEN

The Council had an full ranging discussion and agreed that the following points be pursued:-

- In 2015 the Council undertook a consultation on speed limits and suggest 40mph notices to be introduced and nothing has happened.
- Ask if the 2500 signs that are not needed have been signed off so they can be removed.
- Removal of bollards around Porchfield War Memorial
- Triangle at Underwood Lane and also on the other side.
- Road outside Calbourne Mill.(490/2016 ref 16088363) Various surveys have been done and recommendations made. When is something going to be done on this stretch of highway.
- It was reported at the County Hall Meeting that the enforcement list was being scrapped and that in future Parishes email individual enforcement problems to Wendy Pereira and not lump a number of enforcement problems together.
- The matter of people living on land West of London Farm was raised and the fact that they had been given 2 letter boxes which was not allowed.

- Littlefields Cross on Forrest Road about 50 metres of hedge has been taken out.
- Thorness Bay failure to do tree planting and a conditioinb nwas no occupation tillthey do their planting Scheme.
